New Project/Program (score 0-5)

- Is this application from an organization that hasn't applied in the past?
- Is this application from an organization that is a past recipient but for a different project/program?
- Is this application for an ongoing large project that has been broken into phases (each phase is considered a new project)?
- Is this application for a new program or project to the community?

Use of Local Resources (score 0-5)

- Is the organization able to hire or purchase items from local businesses/trades? (BRCF wants to encourage organizations to "shop local" if possible)
- Is the Organization able to use any volunteer labour/input to complete the project/program?

Target Audience

- #s Served (score 0-10)
 - Is this project/program open/accessible to all residents or club/organization members only?
 - How many people are impacted by the project/program?

• Deomgraphics (score 0-10)

- What age groups does the project/program serve?
 - children/youth
 - adults
 - seniors
- Will the project/program be accessible to the following marginalized populations?
 - Low income
 - Persons with disabilities
 - Newcomers
 - Indigenous community
 - Other
- o Does this project/program demonstrate sensitivity to:
 - Diversity
 - Accessibility
 - Inclusivity

Geographic Area Served (score 0-10)

- What geographic regions does the project/program serve?
 - o Beausejour only
 - RM of Brokenhead only
 - All of Beausejour and Brokenhead
 - o All of Beausejour and Brokenhead and surrounding communities



Scoring Explanations & Considerations

Community Engagement (score 0-10)

- Is this a collaborative project involving partnership/engagement from other community service organizations?
- Will the project promote volunteer participation and citizen involvement?

Demonstrates Need and Impact (score 0-10)

- Does this grant request support the needs of the organization?
 - Does grant request enhance the organization's service and impact within the community?
- Does this grant request serve a community need?
 - Are there other organizations operating similar projects/programs?
- Is this going to make a positive and lasting impact in the community?

Financial Commitment (score 0-10)

- What level of financial commitment does the organization show towards the project/program?
- Has the organization secured funds to support a minimum of 25% of the cost?
- Can the project/program be completed if we can only partially fund?
- Has the organization reached out to other sources for support?
- Will the project be realistically completed by the August 31st deadline?

Sustainability (score 0-10)

- Is there a clearly defined method of evaluation to measure the outcome of the project?
- If this is not a one-time program or capital project, is there active planning for continuation of the project beyond initial funding?

BRCF Impact (score 0-10)

- What is the potential impact on the Brokenhead River Community Foundation in funding this project?
 - In what ways is the organization able to promote our contribution to their project/program (visual recognition, media coverage, social media etc.)
